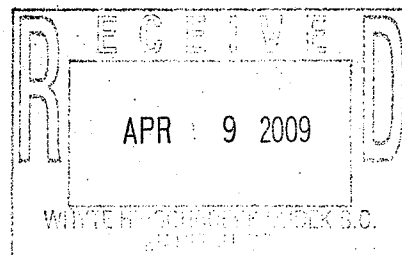
You are hereby notified that the Court has entered the following order:

Wisconsin Medical Society v. Morgan L.C.#2007CV4035

The court having considered the motion filed by Wisconsin Association of Justice to extend the page limit of its *amicus curiae* brief, and a request by *amicus curiae* Advocates for Medicaid Patients to participate in oral argument on the same terms as the court has allowed the *amicus curiae* Wisconsin Association of Justice to participate in oral argument;

IT IS ORDERED that the motion filed by the Wisconsin Association of Justice to extend the page limit is granted and the brief is accepted for filing;



IT IS FURTHER ORDERED that the request of *amicus curiae*, Advocates for Medicaid Patients, to participate in oral argument is denied.
